- 5. The Northfield Community School District will take the following actions to conduct, with the involvement of parents, an annual evaluation of the content and effectiveness of this parental involvement policy in improving the quality of its Title I, Part A schools. Children are referred to any team member listed, who will immediately begin the process of bringing a parent/guardian into the support of dynamics for the student, school, and district. The ESL support personnel have an open online support period twice weekly for support of parents and families.
- 6. The Northfield Community School District will build the schools' and parent's capacity for strong parental involvement, in order to ensure effective involvement of parents and to support a partnership among the school, involved parents, and the community to improve student academic achievement, through the following activities specifically described below:
